

# Angus L. Campbell

Angus L Campbell was the 4th and youngest son of Daniel Douglass Campbell and Nancy McLean Campbell. He was born in Euchee Valley, Eucheeanna, Walton County, Florida on November 19, 1852. He was also the 15th child in the family. As a youth he was surrounded by a loving and caring family.

The family was self-sufficient, making or growing everything to meet their needs. The sheep were sheared, the wool carded, spun and woven into clothing or blankets. Corn meal, ground locally, provided their bread. Cattle, sheep, chickens and pigs provided fresh and smoked meat. This was supplemented with wild game.

Sundays were a day of rest. Children were not punished, no games played, no cooking and the only work was the care of the farm Angus L. Campbell animals and fowl. Sundays were a day of rest, reflection and prayer. Most of the day was spent at church. The men and boys sat on one side of the aisle and the women and the children on the

During the invasion by General Asboth's troops, enroute to Marianna, Angus and a young servant boy, rounded up as many horses and cattle as they could and drove them into the swamp areas to keep them out of the Yankee hands. Angus was a scout for the Home Guard, commanded by Captain John Gillis.

One of Angus' older brothers, Dr. Daniel L. Campbell was the company physician. The Federal troops did tear up the split rail fences, which they used for their campfires. The troops did kill and eat his favorite lamb.

When the troops left, they took the male servants with them and left the women and children. Angus was the only physically able male left at home. His father was in his 80s and blind (probably cataracts) so it fell on Angus' young shoulders to care for his family of mother, father, sisters and the remaining servants. The smoke house had been cleaned out; so food became the top priority.

Next, his father died in 1867 and he took over full responsibility for his mother. The other siblings deeded their shares of the estate to him for the care of his mother and unmarried sisters. He was then a fulltime farmer, but primarily a stockman.

It was open range in Florida. so rounding up cattle for marking in the spring was an arduous task with the cattle ranging for miles in any direction. Angus was an expert horseman. His favorite

mount was a buckskin which he named Traveler in honor of General Robert E. Lee's horse. He would drive the cattle to Freeport to meet the cattle boats. This would take a couple of days. They were paid in silver dollars. The saddle bags would be so heavy they could barely lift them.



Christian Currie Bowers Campbell

In 1880, Angus married Christian Currie Bowers, (B: August 11, 1860 - D: October 27, 1887). She was the daughter of James Bowers and the granddaughter of Giles Bowers, Sr. Dr. Daniel L. Campbell married Christian's older sister, Elizabeth.

They were blessed with three children, Sarah Jeanette Campbell, born September 10, 1882 died: December 5, 1975; James Bowers Campbell, born August 24, 1884-died: March 4, 1969 (became a Judge); Daniel Currie Campbell, born: 1886 - died: 1963 (became a physician). Then more heartaches, Christian's parents became ill with fever and she went to take care of them.

They had typhoid fever from the well water. Christian also became ill with typhoid and died October 27, 1887, leaving her husband and three children. The day before she died Aunt Abbie was cooking

chicken and she begged for some chicken soup. It was her final meal. Fortunately, Angus's unmarried sisters lived with him and they lovingly cared for the three children. Each would become highly educated, with Sarah Jeanette graduating from Florida State College for women, James Bowers graduated from Stetson University and Stetson Law School, Daniel Currie graduated from the University of Tennessee and the University of Tennessee Medical School.

Angus was an active member and an Elder in the Euchee Valley Presbyterian Church. He also served on the Walton County School Board. His unmarried sisters died, Sarah, April 17, 1926 and Abigal, June 26, 1927. At that point he chose to live with his daughter and her family in Quincy. He also made extended visits to his son Judge J. Bowers Campbell who was then living in Ft. Myers. This was probably the furthest away from home he ever ventured.

He died in Gadsden County, outside of Quincy, on St. Patrick's Day, March 17, 1933. He insisted on living in the country and considered Quincy a large town. He attended the First Presbyterian Church, Quincy, every Sunday until his death. He and Mr. May would sit in the front pew, directly under the pulpit, as Dr. H. A Love preached. His death was brought on by kidney failure and all of his children and grandchildren were at his bedside when he died.

His remains were returned to his beloved Euchee Valley Presbyterian Church Cemetery where he was buried in the family plot. The services were attended by both black and white. There were more mourners than the church could hold. As a parting tribute it was said that he never harmed any man. He was the last of the Daniel D. Campbell and Nancy McLean Campbell children. He was not very tall in stature (5'8") but he was big in heart.
