Internet at the Museum

Internet service was installed at the Walton County Heritage Museum in April, bringing the Heritage Association, the Museum, and the Genealogy Society into the 21st century. The service will be paid for with donations received.

The genealogy computer in the east room (the "meeting room") is available for use by members of the Walton County Heritage Association and guests who are pursuing genealogy research. That computer is available during our normal open hours and is equipped with a printer/scanner. If you make more than ten copies while using the printer, we ask that you "Feed the Pig" by dropping a donation into the piggy bank next to the printer. Otherwise, there is no charge for using the equipment.

Wayne Sconiers has generously given us access to Ancestry.com on that computer as well as Family Tree Maker software, and he will be offering classes on the use of those and other programs at future Genealogy Society meetings.

Walton County Newspaper Archives

In April, we were pleased to welcome our newest volunteer intern, **Sarah Capps** of Panama City. Sarah is a history major graduate of Florida State University, and she has been updating our Newspaper Archives database. As of this writing, the database includes items from *The Breeze* newspaper from April 1910 through March 1912. The extracts from those newspapers were compiled by **Michael Strickland** and **Mary Ellen Wexler**, and we thank them for their work. To search the database, go to <u>waltoncountyheritage.org/wp</u>, which will take you to the "Welcome" page. In the top white box, enter a search term, such as a surname or a location, and hit the "Search" button. A list of everything we currently have online for the search term will then be listed. To read more about an item, click the title of the item, such as "The Breeze – May 2, 1912 – General News," and you will be taken to the complete entry.

Biographical Rosters -- Page 37, Milton, Stephen R. enlisted 7/21/61 at Marianna and reenlisted in (New) Company D, 1st Florida Infantry in early 1862. He was captured at Murfreesboro 1/2/63 and sent to Jefferson Barracks prison. He died of pneumonia in the St. Louis City General Hospital 1/29/63 and was buried in the prison cemetery, grave #10004.

1860 Santa Rosa Co. Census - Daniel Moore, Page 25, Family # 173, 17 years old, no occupation listed.
Biographical Rosters - Page 104, 2nd Cpl. D. D. Moore enlisted 3/1/62 at Camp Walton. He was absent sick since late 1862 and dropped after February 1863.

Soldiers of Florida - Page 67, Moore, Daniel D., corporal, Dec. 29, 1861, letter written at Camp Walton from Alexander McDonald to Duncan A. McDonald, "The funniest thing that happened was after the party broke up at number 3. It was Miss Nancy kissed Daniel Moore. They looked like two Kittens a playing when they went to kiss. . . . Daniel Moore says that he is due you a letter but had no paper. He says you must excuse him and also ... of the family that he will write as soon as he gets paper." Original in the Heritage Museum of Northwest Florida, Valparaiso.

Moore, John

1860 Walton Co. Census - John Moore, Page 60, Family #403, 30 years old, farmer, wife - Elizabeth, and 5 children.

Morrison, Arch. G., Lieut.

1860 Walton Co. Census - Archy Morrison, Page 38, Family # 259, 16 years old, serving.

Biographical Rosters - Page 655, 1st Sgt Archibald Gillis Morrison (b. 1844; m. single; d. 12/16/64 Nashville) enlisted 4/2/62 at the Mt. Vernon Arsenal and was promoted 3rd Lt 8/12/63. He was accidentally shot in the back by US soldiers after surrendering near Nashville 12/16/64. According to John McKinnon, his last words were, "I had hoped that it might have been different with me at the end; but it is all right." He died later that evening and was buried on a mountainside near where he was shot. McKinnon visited the grave site in 1896 while attending the Confederate Reunion in Louisville KY. Father: John; Mother: Christian Campbell.

Soldiers of Florida - Page 167, Morrsion, Archibald G. enlisted April 2, 1862, 1st sergeant.

1860 Walton Co. Census - Malcom Morrison. Page 4, Family # 24, 23 years old, laborer. *Biographical Rosters* - Page 100, Morrison, Macomb P. (b. 1836) enlisted 2/28/62 at Camp Walton and died 12/15/62 in camp at Eagleville TN. He was 5'10", fair skin, blue eyes, dark hair, occupation:

farmer. Father: Murdock.

1860 Walton Co. Census - Joseph Nelson, Page 29, Family # 190, 21 years old. farmer. Biographical Rosters - Page 108, Nelson, Josiah (b. 1839) enlisted 3/1/62 at Camp Walton. He was captured 10/11/62 in Harrodsburg KY and exchanged at Vicksburg in late 1862. He was 6', grey eyes, light skin & hair. He died 1/31/63 in a Vicksburg Hospital and was buried in a local Confederate cemetery, potter's field grave #724m in the North West Quadrant, Section B.

Soldiers of Florida - Page 67, Nelson, Josiah died at Harrodsburg, Ky., February 28, 1863.

1860 Walton Co. Census - Dosier Padgett, Page 30, Family # 202, 20 years old, farm laborer.

Biographical Rosters - Page 662, Padgett, Dozier (b. 1840) enlisted 4/2/62 at Mt. Vernon and was killed at Chickamauga 9/19/63.

Soldiers of Florida - Page 167, Padgett, Dozier enlisted April 2, 1862.

Ray, Colin G., Jr.

1860 Walton Co. Census - Colen Ray, Page 9, Family # 17, 17 years old, serving.

Biographical Rosters -- Page 662. Ray, Colin G. Jr. (b. 1843) enlisted 4/2/62 at the Mt. Vernon Arsenal and died of pneumonia 10/30/62 in Knoxville. Mother: Flora G.

Soldiers of Florida - Page 167, Ray, Colin G. Jr. enlisted April 2, 1862.

Ray, Colin G., Sen.

1860 Walton Co. Census - Colin Ray, Page 7, Family # 46, 21 years old, farmer.

Biographical Rosters - Page 662, Ray, Colin G. Sr. enlisted 4/2/62 at the Mt. Vernon Arsenal and was absent on the last roll.

Soldiers of Florida - Page 167. Ray, Colin G. enlisted April 2, 1862.

Gillis-McLean Papers, University of Florida Library, June 11, 1864, letter from A. G. McLeod to Mr. Daniel Gillis, "1 suppose you have heard before now the sad casualties and particulars of the fight on the 28th of last month in which Col. McLean and Colen Ray were killed. Colen lived till next day, the Col. only a few minutes."

Reddick, Madison M.

1860 Walton Co. Census - Madison Reddick, Page 23, Family # 151, 23 years old, boating. Biographical Rosters - Page 103, 5th Sgt Madison M. Reddick enlisted 3/1/62 at Camp Walton. He was wounded in both legs at Murfreesboro 1/2/63 and died 1/8/63 after his right leg was amputated by Dr. C. J. Walton, 21st Kentucky. He appears as 4th Sgt in early 1863. Soldiers of Florida - Page 67, Reddick, Madison M., sergeant.

Reddick, Martin

1860 Walton Co. Census - Martin Reddick, Page 23, Family # 151, 18 years old, boating.
