





Eliud Bowers Family Heritage

Our family records show that Edward Bowers was born abt. 1790 in VA. He was married to Rebecca, last name unknown. Of this marriage was born 3 children, 1. Giles Bowers, born 06-06-1814 in Colleton District, SC. Died, 01-15-1876 in Walton County and is buried in Euchee Valley Cemetery. Married Christian Curry McKinnon in 1845. 2. James Edward Bowers, born 03-04-1817, in Laurens Co., Georgia. Died 12-13-1899 in Walton County and is buried in Euchee Valley Cemetery. 3. John Wesley Bowers (my Great- Great-Grandfather), born 08-26-1819, in Laurens Co., Georgia. The history records show that he came to Walton County sometime before 1845 because his first child, Michael Bowers was born 08-28-1845. moved to Texas before 1880. Died 02-25-1899 in Rusk Co., TX and is buried in Old Prospect Cemetery, Rusk Co., TX. He married first to Sarah McCaskill, born in SC in 1825. Died on 06-24-1870 in Walton Co. Buried in Euchee Valley Cemetery # 331. After her death John Wesley married Frances Providence Rigdon.

My name is Charlot Evon Bowers, Lindsey. John Wesley Bowers and Sarah McCaskill, Bowers are my Great-Great- Grandparents. Michael was my Great Grandfather. He and 2 of his brothers (William L. And Fenley A. Bowers) remained in Walton County when John Wesley moved to Texas.

Children born to John Wesley and Sarah Bowers: 1. Michael Bowers, born 08-28-1845 in Walton County, FL.

Died 09-16-1924. Buried in Euchee Valley Cemetery (#336); 2. William L. Bowers, born 1847. Died 1875. Buried in Euchee Valley Cemetery. Married Nancy M. McLeod; 3. Fenley A. Bowers, born 1849 in Walton Co. FL. Buried in Euchee Valley Cemetery (#332); 4. Giles Wesley Bowers, born 03-1852 in Walton Co. Died 1905 in Panola Co., TX. Married the first time to Laura Susan Johnson on 02- 03-1881. His second marriage was on 05-02-1901 to Leila Polk; 5. Belle Anne Bowers, born abt. 1854. Married on 01-19-1881 to E. J. Evans; 6. Mary Jane Bowers, born 1856, died 1901, buried in Panola Co., TX. Married to W. J. Thomas; 7. Fatima Bowers, born abt. 1859. Died on 03-30-1881. Buried in Panola Co., TX.

Michael Bowers married first to Abbie (maiden name unknown). She was born in 1847, in FL. Died 01-13-1891 in Walton County, FL at age 44. She now rests in the Euchee Valley Cemetery (#337). Michael married the second time to Martha A. "Massie" Linton.

Children born to Michael and Abbie Bowers (my great- grandparents) (1) Daniel Bowers (2) M. T. Bowers, born 1870 (3) K. A. Bowers, born 1872 (5) Carrie Bowers, born 1874 (6) Eliud Bowers (my Grandfather), born 02-02-1877, died 10-10-1965. Buried in Euchee Valley Cemetery. Married Quittie Moore in 02-1909 and now rest beside Granddaddy in Euchee Valley Cemetery. (7) Lewis E. Bowers, born 1879. (8) Giles Bowers, born 1882. (9) Sara "Abbie" Bowers, born 1885. (10) Wesley Bowers, born 11-1887, died before 1960. (11) Jessie Bowers, born 07-1888, died before 1960.

Children born to Eliud and Quittie Bowers: 1. Clarence Bowers (my Father), born 05-03-1918, at home in Ponce de Leon, Florida, He died on 01-02-1982 and now rest in the Red Bay Cemetery in Walton County, Florida. Married my Mother, Alma Lee Odom of Red Bay, FL.; 2. Mary Louise Bowers, born 06-18-1919, died 11-21-1925. Buried in Euchee Valley Cemetery.

My early memories of my Grandfather (Eliud

Bowers) are of the years when we lived with him in a log cabin off Morrison Springs Road in Ponce de Leon. remember the cabin well. There was only one main room with a kitchen lean-to added on. There was no electricity, just an oil lamp for light. There was a fireplace with a stick and dirt chimney, Granddaddy would sit by it to read his Bible. Mother cooked on a wood stove, which felt good in the winter but was awful hot during the summer. We would wash dishes in dishpans with water drawn from a picture pump, and throw the water out the kitchen window onto some red canna lilies that Mother had planted outside. I can remember the windows being just an opening in the wall and having large shutters to close at night. There was so many of us kids that it was wall to wall beds, all in the same room along with Daddy, Mother and Granddaddy. When our cousins came to visit we would have to sleep sideways in the bed to have room. There was a small barn out back with a corn crib up top. Us kids used to play in the crib. I can still remember the muskey smell of dry corn and the weevils getting in our clothes and tickling. Oh! How I loved to be in the crib when it rained on the tin roof. There were huge persimmon trees in the front of the cabin that bore fruit and tasted quite good when ripe, but sure turned your mouth "wrong side out" when they were green. We discovered that if we cracked a seed open carefully there would be a perfect "spoon and fork" inside. We never wore shoes around the house and persimmon squashing up between your toes feels pretty nasty.

Granddaddy was a very religious man and he would set and read the Bible a lot. I can see him now in a straight chair in the doorway, with his Bible in his lap. He was "Church Of Christ" by faith and he believed in going to church if he had to walk. He loved to sing gospel songs and sometime would get up in church and speak a little when he was at a church without a pastor and the men would take turns speaking. I remember going to church with him up toward Prosperity and as a child it seemed like it was a very

long way up there from Morrison Springs.

The only income Granddaddy had was a monthly welfare check for \$81.00. Mother said he lived off it and manage to save some. He bought the land where the cabin sat and paid a little each month out of his check. He farmed the land and lived off what he grew. I have heard Mother say that he had to have greens cooked almost every meal, and he would not allow anyone to go into his green patch. He would give a "mess" to anyone but he would have to do the picking. I can remember, just plain as day, how he walked behind our plow horse "Molly". He worked acres of corn with a single blade plow. I can remember the bad job of stripping fodder for the cows and molly to eat all winter.

As the years passed, Mother and Daddy built the "big new house" where mother lives today. Granddaddy moved in with us to his room in back and as I remember he was the first one to tell me the story of Jesus. I feel like the faith I have today, began with his teaching. In the later years he developed hardening of the arteries and started having seizures and eventually lost his mind and couldn't speak. Granddaddy passed on, but his spirit still lives with all of us. He was a kind, gentle man but according to Mother, he had some peculiar ways. It took some persuading to get him to allow her a small garden space to plant as she pleased.

Grandmother passed on before Mother and Daddy were married. I am sad to say that we don't have any memories of her. My Mother has told me that she was a quiet woman that pretty much did as Granddaddy ask. He would never let anyone go in his green patch and she didn't go in it herself.
